- Restriction: Request limited processing of your data.
- Data Portability: Request your data in a structured, machine-readable format.
- Objection: Object to the processing of your data for specific purposes.

We implement appropriate technical and organizational measures to ensure the security of your personal data.

However, no system is completely secure, and we cannot guarantee absolute data protection.
